The Supplier reserves the right to register this document with the "Registre des Droits personnels et Réels mobiliers (RDPRM)".
- Relative to the Customer's solvency, the Customer agrees to let the Supplier access any necessary information (credit report) from any financial institution or firm, in the measure where it will be used for this purpose in a proper course of business.
- The signatory for the purposes hereof agrees that any judicial proceedings necessary will be filed in the judicial district of Quebec and declares to renounce any other judicial district.
